1. Request for Direct Crediting of payments
 - Part A of this form must be completed in full if you wish your Cash Consideration or the cash element payable pursuant to the Partial Share Alternative (as applicable) to be paid directly into your nominated South African bank account. Until cancelled in writing by you, all future cash payments will be paid into the nominated account.
 - Please do not use the number quoted on your credit or debit card.
2. By signing this form you:
 - Confirm that the details are true and correct.
 - Understand that SABMiller, AB InBev, Newbelco and the SABMiller South African Registrar, Computershare Investor Services Proprietary Limited, are not obliged to post a cheque to you in relation to the Cash Consideration or the cash element payable pursuant to the Partial Share Alternative (as applicable) in the event that we are unable to transfer the funds due to you electronically and any decision to do so will be at the sole and absolute discretion of AB InBev on a case by case basis.
 - Agree that if AB InBev determines that a cheque will be sent to you by post, it will be at your own risk.
