Biography of Baron Paul De Keersmaeker Honorary Chairman of Interbrew

Baron Paul De Keersmaeker was born in 1929 and holds degrees Doctor of Law, Bachelor of notary, University of Leuven (KUL). He began his career as Manager of the family brewery De Keersmaeker N.V. in Kobbegem (near Brussels).

Paul De Keersmaeker developed an excellent business and public service career. From 1959 to 1985 he was mayor of Kobbegem/Asse, from 1968 to 1992, member of the Belgian Parliament, from 1974 to 1981 Member of the European Parliament, from 1981 to 1992 Member of the Federal Government as Secretary of State for European Affairs and Agriculture.

Paul De Keersmaeker joined Interbrew as Member of the Board in 1992 and was appointed Chairman of the Board in 1994. He is Chairman of the Board of Domo, Nestlé Belgilux, and WDP, Vice-Chairman of the Board of Euler-Cobac and Member of the Board of Tractebel, Iris and Afinia Plastics.

Upon expiration of his mandate as Chairman of the Board of Directors of Interbrew at the General Shareholders Meeting of 24 April 2001, Paul De Keersmaeker was appointed Honorary Chairman of the Company. He is also Honorary Chairman of the Board of KBC Bank, the Federation of Food Industry and the Confederation of Belgian Brewers.

Between 1992 and 1998 Paul De Keersmaeker was Chairman of the Confederation of Belgian Brewers and of the Federation of Food Industry as well as Member of the Management Committee of the Federation of Enterprises in Belgium.

Paul De Keersmaeker is European Chairman of the Canadian European Round Table and Chairman of the Foundation Europalia International.
